membership is down from two years ago. I would love to see it back up to 30-35. I plan to contact some of our past members and try to get them back.





FEBRUARY REAGAN CAMP MEETING & HISTORICAL PROGRAM



"AN EXAMINATION OF SOUTHERN BLACK PATRIOTS DURING THE WAR BETWEEN THE STATES"

The February meeting was held on February 24th in the Commercial Bank of Texas meeting room. The night started off with a delicious meal of barbeque, meatballs and gravy, beans and cornbread, and casserole.

After the meal, we were honored to have Dr. Bill Hardy present the February historical program. Dr. Hardy's great-great grandfather served as a Body Servant during the War Between the States. He had some personal family stories that he told about his family and his great-great grandfather.

1st Lt. David Franklin said, "the program was a fascinating look at Mr. Hardy's ancestors and their unique aspects as both slave and free men who saw their Southern heritage as a matter of pride. These ancestors had a loving relationship with Slave owners, a narrative that is pretty much ignored these days. This was a superb program of an oft neglected part of our history."

Dr. Hardy currently serves as a Minister and as an Elder for the Palestine Church of Christ in Palestine. Over the past 45 years, he has also served as a youth minister, senior minister, elder, and missionary. He has served as a director at church youth camps, spoken at church lectureships, and served as an instructor at evangelistic workshops.





He has also served on the board of directors of various civic and ministering organizations.

Dr. Hardy worked in the department of psychiatry in VA hospitals and the Federal system in Oklahoma and Kansas for 15 years before being recruited by the University of Texas Medical Branch (UTMB) in 1996. He worked there for 23 years providing psychiatric care via UTMB contracted services within the Texas Department of Criminal Justice before retiring in 2017.

Bill was commissioned as a Medical Officer in the Army National Guard in 1983 and rose to the rank of full Colonel before retiring after 33 years of service.

We appreciate Dr. Hardy so much for the excellent program and for all that he does and has done for our community. It was an honor to meet him and to have him join us for our meeting,.




A GREAT WAY TO ENSURE THAT YOUR ANCESTOR'S SERVICE AND HONOR IS NOT FORGOTTEN



TEXAS CIVIL WAR HISTORY IN FEBRUARY

February 1, 1861 - On this date, Texas became the 7th state to secede from the Union when a state convention voted 166-8 in favor of secession. Even though Sam Houston objected to Texas leaving the Union, the vote passed.

February 2, 1861 - On this date, a declaration of the causes which impel the State of Texas to secede from the Federal Union was adopted.

February 2, 1861 - On this date the Committee of Public Safety directed to seize all federal property in Texas.

February 9, 1861 - On this date, a proclamation by Gov. Houston setting an election on the Ordinance of Secession.

February 16, 1861 - On this date, the US Army Facility at San Antonio was seized under authority of the Texas Committee of Safety

February 18, 1861 - On this date, US General David E. Twiggs surrendered all US military posts in Texas.

February 19, 1861 - On this date, Carlos A. Waite replaced Gen. Twiggs as US Army commander, Department of Texas.

February 21, 1861 - On this date, Volunteers under the command of John 'Rip' Ford seize U.S. property at Brazos Santiago in the Rio Grande Valley.

February 23rd, 1861— On this day in 1861, the people of Texas went to the polls to vote on a referendum to secede from the Union. The vote was 46,153 for secession and 14,747 against. Of the 122 counties casting votes, only eighteen cast majorities against secession. Only eleven others cast as much as 40 percent against. The referendum was held pursuant to a decision in favor of secession in the state Secession Convention.

February 27th, 1850 - On this day in 1850, Carlos Esparza, a supporter of the Mexican folk hero Juan N. Cortina, and various followers attempted to establish a territorial government and separate themselves from the rest of Texas. The territory of the Rio Grande was intended to protect the interests of Hispanics, but the proposal became politically complicated and was dropped. Esparza, born in Matamoros, Tamaulipas, in 1828, was to all appearances an ordinary rancher possessing neither Cortina's striking appearance nor leadership qualities. The eccentric, sharp-tongued Esparaza remained Cortina's man in the shadows, however. During the Civil war, he managed to aid Union and Confederate forces against each other while promoting the Cortina's cause.

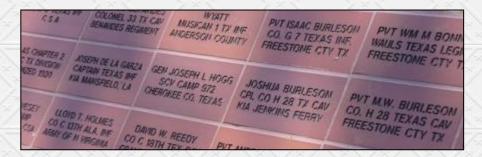


CONFEDERATE VETERANS MEMORIAL PLAZA INFORMATION

The citizen-soldiers who fought for the Confederacy personified the best qualities of America. The preservation of liberty and freedom was the motivating factor in the South's decision to fight the *Second American Revolution*. The tenacity with which Confederate soldiers fought underscored their belief in the rights guaranteed by the Constitution. These attributes are the underpinning of our democratic society and represent the foundation on which this nation was built.

Today, the **Sons of Confederate Veterans** is preserving the history and legacy of these heroes, so future generations can understand the motives that animated the Southern Cause.

The SCV is the direct heir of the United Confederate Veterans, and the oldest hereditary organization for male descendants of Confederate soldiers. Organized at Richmond, Virginia in 1896, the SCV continues to serve as a historical, patriotic, and non-political organization dedicated to ensuring that a true history of the 1861-1865 period is preserved.

Membership in the **Sons of Confederate Veterans** is open to all male descendants of any veteran who served honorably in the Confederate armed forces. Membership can be obtained through either **lineal or collateral** family lines and kinship to a veteran must be **documented genealogically**. The minimum age for full membership is 12, but there is no minimum for Cadet membership. **Friends of the SCV** memberships are available as well to those who are committed to upholding our charge, but do not have the Confederate ancestry.
