COMMANDER'S DISPATCH



Camp Events



This Lone Star Battle Flag of the First Texas Infantry was known as the "Wigfall Flag." The 5 x 8 foot silk flag was made by Mrs. Louis T. Wigfall, and presented to the regiment in 1861. The battle honors were added in the summer of 1862. The Wigfall flag, along with 9 flag bearers, was lost in what was arguably the most vicious fighting of the war at Sharpsburg, Maryland on September 17, 1862.



2 Lt. Commander Dale Roberts presented an excellent Historical Program on the H.L. Hunley Submarine & the men who were willing to risk their lives for the confederacy.



This file has been identified as being free of known restrictions under copyright law, including all related and neighboring rights.

The H.L. Hunley was a submarine of the Confederate States of America. It played a large role in the history of naval warfare by being the first submarine to sink an enemy warship. 21 confederate soldiers lost their lives during the short time that the submarine was used. The Hunley sank on Feb 17, 1864, after attacking and sinking the USS Housatonic in Charleston's outer harbor. The submarine was recovered in 2000 & is on display in Charleston.

They were men of prayer. President Jeff Davis, Generals Robert E. Lee, Thomas J. Jackson, Nathan B. Forest, and many others. From the greatest generals to the newest recruits, the men in gray believed in the presence and providence of Almighty God. 

The citizen-soldiers who fought for the Confederacy personified the best qualities of America. The preservation of liberty and freedom was the motivating factor in the South's decision to fight the *Second American Revolution*. The tenacity with which Confederate soldiers fought underscored their belief in the rights guaranteed by the Constitution. These attributes are the underpinning of our democratic society and represent the foundation on which this nation was built.

Today, the **Sons of Confederate Veterans** is preserving the history and legacy of these heroes, so future generations can understand the motives that animated the Southern Cause.

The SCV is the direct heir of the United Confederate Veterans, and the oldest hereditary organization for male descendants of Confederate soldiers. Organized at Richmond, Virginia in 1896, the SCV continues to serve as a historical, patriotic, and non-political organization dedicated to ensuring that a true history of the 1861-1865 period is preserved.

Membership in the **Sons of Confederate Veterans** is open to all male descendants of any veteran who served honorably in the Confederate armed forces. Membership can be obtained through either **lineal or collateral** family lines and kinship to a veteran must be **documented genealogically**. The minimum age for full membership is 12, but there is no minimum for Cadet membership. **Friends of the SCV** memberships are available as well to those who are committed to upholding our charge, but do not have the
